OVMA dues are not deductible as charitable contributions for federal income tax purposes. However, they may be deductible as business expenses, except that portion which is attributed to OVMA lobbying expenses. OVMA estimates 15% of your 2019/20 dues is attributed to lobbying and is non-deductible. Contributions to DVM-PAC are non-deductible and must be from non-corporate funds. Contributions to the OACF are deductible as charitable contributions.
